#### ISO 27001

ISO/IEC 27001:2013 (ISO27001) is the international standard that provides the specification for a best-practice Information Security Management System (ISMS). We were first certified as ISO 27001 compliant in 2014 and continuously improve our information security practices. We take the security of our customers' information extremely seriously. In 2021 we not only re-certified for ISO27001:2013 but obtained the ISO22301:2019 international standard for a best-practice Business Continuity Management System (BCMS). Our ISO certifications provide us with an integrated management system for managing our regulatory obligations, identifying our potential risk factors and ensuring our procedures are up to date.

In light of our new approach to measuring our CO2 emissions and the new way of working, we've put our goal of ISO14001 accreditation on pause. However, we will kick this off again in 2023 and will target certification by no later than December 2024.

SO14001 is a crucial tool in communicating our commitment to the environment to our business partners, the insured, our colleagues and potential colleagues of tomorrow.



## Environmental Impact

"We have taken a fresh new approach to measuring our environmental impact this year in a bid to better understand where we can make a difference in the future. Our 2021 emissions are our most accurate calculation ever, and include all international recognised scopes of emissions; 1, 2 and 3. As a result, our CO2 emissions are greater than in previous years, but this far better reflects our true impact on the environment. However, 2021 may not be our ideal benchmark against which to make informed commitments into the future, because it was a year disrupted by the global Covid pandemic. Our 2022 figures, when published next year, will give us a far better foundation. This is an exciting step in our environmental evolution, and no doubt a precursor to ISO27001 accreditation."



### **Carbon Offsetting**

We have offset **318 tonnes** to cover our 2021 emissions of **317.20 tCO2e**.

This was undertaken via Ecologi and gives us a true negative net emissions figure of **-0.80 tCO2e**!

From 2019 ARAG has offset our carbon usage. This year we have offset via **Ecologi** and a Wind power project in Thailand.
