#### What are the advantages of using an ARAG pre-approved law firm?

Unlike some of our competitors, ARAG has made a conscious decision not to own a law firm or carry out legal work in-house. We have instead selected, vetted and approved a hand-picked network of lawyers who are entirely independent to ARAG. We strongly feel that this results in many benefits which are set out further below:

- If you utilise the services of an ARAG pre-approved law firm to pursue your claim, all costs incurred by the legal representative will be covered by your ARAG policy from the outset; subject to your claim meeting the policy criteria.
- We have preferential rates agreed with our pre-approved law firms due to our commercial arrangements with them, which ensures that the 'cost of success' is lower than the usual market rates for private-paying clients, without compromising on service. In employment claims, costs are rarely recoverable from the other side, meaning that that you will be personally exposed to any costs incurred outside the policy limits.
- Our commercially advantageous arrangements also mean that you can utilise a comparable or indeed sometimes, higher grade of solicitor to handle your case for lower rates, which protects your policy limit of indemnity (the maximum amount payable under the policy). The protection of your policy limit of indemnity is important as this will ensure that your risk for personally incurring legal costs is reduced.
- Our pre-approved law firms are tried and tested and subject to ongoing performance reviews to ensure that they deliver the highest standards of service to our policyholders. This quality control is simply not possible with non-approved firms.
